RE: Freedom of Information Act Request for Final Opinions, Including Concurring and Dissenting Opinions, as Well as Orders, in the Adjudication of Cases for Investigations of Complaints Filed Against Immigration Judges Since January 1, 2009

Dear Ms. Stevens:

This letter is in response to your Freedom of Information Act (FOIA) request in which you seek the final opinions, including concurring and dissenting opinions, as well as orders, in the adjudication of cases under the supervision of Marybeth Keller and decided by employees of the Executive Office for Immigration Review (EOIR) for investigations of complaints filed against immigration judges since January 1, 2009, and that were not forwarded to the Department of Justice Office of Professional Responsibility.

Pursuant to your telephone conversation with Cecelia Espenoza, you agreed to modify your FOIA request for the Immigration Judge Complaint database. You also indicated that if you seek any additional documents that a new FOIA request would be submitted to EOIR.

The enclosed computer disk contains closed cases from the Immigration Judge Complaint database. In addition, EOIR is providing a key which assigned a random three letter code to each immigration judge. This key is linked to the complaint number in the database. Please note that the records have been redacted pursuant to 5 U.S.C. § 552(b)(6) to avoid a clearly unwarranted invasion of personal privacy and 5 U.S.C. § 552(b)(7)(C) to protect law enforcement exempt information where the release could reasonably be expected to constitute an unwarranted invasion of personal privacy. To view the contents on the disk, you will need to use computer software such as Adobe Acrobat and Microsoft Excel. Additionally, there will be no charge for this information.

For your information, Congress excluded three discrete categories of law enforcement and national security records from the requirements of the FOIA. *See* 5 U.S.C. § 552(c) (2006 & Supp. IV 2010). This response is limited to those records that are subject to the requirements of the FOIA. This is a standard notification that is given to all our requesters and should not be taken as an indication that excluded records do, or do not, exist. *See* <http://www.justice.gov/oip/foiapost/2012foiapost9.html>.

If you are not satisfied with this decision, you may file an appeal by mail to: Director, Office of Information Policy (OIP), U.S. Department of Justice, 1425 New York Ave., N.W., Suite 11050, Washington, D.C. 20530, or you may submit an appeal through the eFOIA portal at <http://www.justice.gov/oip/efoia-portal.html>. OIP must receive your appeal within 60 days of the date of this letter. If you submit your appeal by mail, both the letter and envelope should be clearly marked "Freedom of Information Act Appeal." The procedures for appeal are stated at 28 C.F.R. § 16.9.
