GEO maintains a daily VWP folder of the detainees that participate, were they are assigned to work and how much they are paid. La Salle states that they do not utilize ERO detainees in their VWP because they do not stay there long enough (on average about a week). Furthermore, La Salle only offers kitchen VWP.
