ORDER

This cause having come before the Court on the *Intervenor Motion For Order To Obligate Parties To Notice All Motions To Intervenor And To Declare Public All Records For 2020 CH 04431 Previously Released By Chancery Division* (the “Motion”), the Court having heard from counsel for the Conservator, counsel for the Director of the Illinois Department of Insurance (the “Director”), counsel for NextLevel Health Partners, Inc. (“NextLevel”), and Intervenor Jaqueline Stevens (the “Intervenor”) appearing *pro se*, and the Court having reviewed the Motion and being otherwise fully informed in the premises;

IT IS HEREBY ORDERED THAT:

1. Subject to the further order of the Court following the hearing set forth in Paragraph 5 of this order, Intervenor shall receive notice of all matters filed in this conservation proceeding, including copies of all motions; and,
2. For the avoidance of doubt, Intervenor’s right to receive notice of all matters filed in this conservation proceeding, including copies of all motions, does not expand Intervenor’s limited right of participation in hearings before this Court as set forth in Paragraph 4 of this Court’s order entered on December 6, 2021, granting Intervenor “leave to intervene for the limited purpose of making arguments regarding the public nature of these proceedings.”
3. Because Intervenor has not been granted as of this date a right of intervention in Case No. 21 L 2873, said case having been transferred, as related to this conservation proceeding, to this Court’s calendar pursuant to an order entered on March 10, 2022, Intervenor presently has no right to receive notice of matters filed in that case; and,
4. The Conservator, the Director, and NextLevel shall file their sur-reply as to any new matter raised in Intervenor’s motion papers, if any, on or before April 26, 2022, and shall provide courtesy copies of same to the Court; and,
5. Oral argument on Intervenor’s *First Amended Intervenor Motion To Vacate Orders Denying Access To Hearings And Records In This Proceeding And Declare Unconstitutional 215 ILCS 5/188.1(b) (4,5)* shall be held on June 8, 2022, at 2:00p.m., on Zoom
