ORDER

This cause coming before the Court for further hearing on the pending *Motion to Vacate Order of Sequestration* (“Motion”), counsel for each of NextLevel Health Partners, Inc. (“NextLevel”), The People of the State of Illinois upon relation to Dana Popish Severinghaus, Acting Director of the Illinois Department of Insurance, (the “Director”), and the Director in her capacity as Conservator of NextLevel (the “Conservator”) having presented argument, and the Court being fully advised in the premises;

THE COURT FINDS THAT:

- A. Neither the Conservator nor the Director have objected to NextLevel’s request that Exhibits A and B to the Declaration of Glenn A. Giese in Support of Agreed Motion for an Order Authorizing and Approving the Member Transfer Agreement Transaction remain under seal; and
- B. NextLevel has made a case that the information referenced in Paragraph 2 of this Order is subject to protection as sensitive to NextLevel’s interests.

IT IS HEREBY ORDERED THAT:

- 1. Exhibits A and B to the Declaration of Glenn A. Giese in Support of Agreed Motion for an Order Authorizing and Approving the Member Transfer Agreement Transaction, which was signed and emailed to the Court on June 24, 2020 and received into evidence pursuant to Order entered on June 29, 2020, will remain under seal.
- 2. NextLevel’s proposed redactions to Paragraphs 13 and 14 of the June 3, 2020 Verified Complaint for Conservation of Assets and Injunctive Relief are accepted, and NextLevel shall file a redacted version of the Complaint containing its proposed redactions to Paragraphs 13 and 14. The original unredacted version of the Complaint shall be kept under seal, and the redacted version shall replace it in the public record.
- 3. NextLevel’s proposed redaction to Paragraph A(iii) on Page Two of the June 9, 2020 Order of Conservation of Assets and Injunctive Relief is accepted, and NextLevel shall file a redacted version of the document containing its proposed redactions to Paragraph A(iii). The original unredacted version of this document shall be kept under seal, and the redacted version shall replace it on the public record.
- 4. The December 6, 2021 hearing on Professor Jacqueline Stevens’s petition to intervene


