We are not certain how to answer your email below. Perhaps this will help:

- You will recall the Court's Nov. 29, 2021 Order which declared that Exs. A and B to the Giese Declaration would remain under seal; there were no other exhibits to the Giese Declaration.

- It is our understanding that the court docket reflects which filings were made and when, but the identities of "filing" attorneys and filing "party" are not always accurately or consistently reflected.
