Dear Ms. Stevens:

This letter is the twenty-seventh interim response to your Freedom of Information Act (FOIA) requests submitted to the U.S. Department of Health and Human Services, Office of the Secretary FOIA Office. Specifically, you requested the following records:

Records tied to the hiring, transfers, and scope of work performed by Lauren Underwood at HHS.

- 1) All position announcements associated with any jobs she held at HHS.
- 2) All reports, memorandums, or analyses she produced, including but not limited to her work on Ebola and other emergency public health matters.
- 3) All travel itineraries.
- 4) All expense reports.

The time frame of this request is January 1, 2010 to January 22, 2017.

For this twenty-seventh release, the Department has reviewed 765 pages of records, potentially responsive to FOIA request. Of these 765 pages, we are releasing 28 in their entirety, while releasing 9 pages in part, with portions redacted, pursuant to Exemption 5 of the FOIA (5 U.S.C. §552 (b)(5)) and Exemption 6 of the FOIA (5 U.S.C. §552 (b)(6)). We have also deemed 723 pages unresponsive to your request. Finally, we have determined that 5 pages should be sent for consultation to other executive branch agencies and returned to this Department for final disposition.

FOIA exemption (b)(5) protects inter-agency or intra-agency memoranda or letters which would not be available by law to a party other than an agency in litigation with the agency. This exemption protects documents that would be covered by any privilege an agency could assert in a civil proceeding. These privileges include, among others, the deliberative process privilege, the attorney-client privilege, and the attorney work-product privilege. Under this exemption, the records being withheld consist of inter-agency and intra-agency correspondence reflecting the

deliberative process of those agencies or legally privileged materials.

FOIA exemption (b)(6) permits a federal agency to withhold information and records about individuals in “personnel and medical files and similar files, the disclosure of which would constitute a clearly unwarranted invasion of personal privacy.” The definition of “similar files” has historically been broadly interpreted to include a wide variety of files, and the United States Supreme Court has held that Congress intended the term "similar files" to be interpreted broadly, rather than narrowly. I have analyzed these records and find they meet the threshold requirement of this exemption. Additionally, we have reviewed and weighed the public interest in disclosure of this information against the privacy interest in nondisclosure and found that the privacy interest outweighs the public’s interest in disclosure. Under this exemption, the records being withheld consist of phone and Blackberry numbers as well as passcodes.

For all exemptions applied, we have found that it is reasonably foreseeable that disclosure would harm an interest protected by one or more of the exemptions to the FOIA’s general rule of disclosure and/or that disclosure is prohibited by law.

We will continue to review the remaining records as efficiently and expeditiously as possible, consistent with the terms of the joint status report and our available resources. Should you have questions or concerns regarding the Department’s response and/or the processing of your request, any such issues should be communicated to your legal counsel and Department of Justice Attorney representing the Department in this matter.

**Subject:** HPP Ebola Part A Administrative Supplement Decision Memo: Change in total cost

All,

As you have may have already seen or should receive shortly, NHPP is routing a Decision Memo requesting to issue an administrative supplement to the HPP Ebola Part A awards. The supplement is intended to bring all designated Ebola Treatment Centers (ETC) up to a minimum funding of \$750,000 in order to complete required activities in the FOA. The additional funding provided to each facility and the total funding request of \$18,463,579.44 on the current memo is based upon the Ebola End-of-Year reports. However, due to a reporting update provided by South Carolina this morning, there is one additional ETCs eligible for this supplement. An additional \$707,151.32 will be needed to be added to the supplement for South Carolina to bring this ETC to \$750,000. Therefore, the new total funding request is \$19,170,730.77 for the HPP Ebola Part A Supplement.

I have updated the Decision Memo, attached. Changes are reflected on page 2 of the Decision Memo and Page 2 of the attachment. Please let me know if you have any questions.

Dr. Lurie, our thinking is a bit more broad. For example, we have assembled many faculty across the academic and research universe (folks from Wayne State, UM, UM-Flint, MSU, Hurley, McClaren) and are expanding that network almost daily. We have an index of over 300 Flint-based projects where investigators voluntarily contributed their project information so they could be known and collaborative. A universal ID for children and adults will allow us to readily link data from these studies to the registry, greatly enhancing our ability to monitor who is getting what and what services and programs are making a difference. As a scientific community we could also establish a set of common core measures across these studies informed by the rich intellectual environment of Flint-based researchers and stakeholders. These investigators have active studies with children and adults and will probably see the distinction as arbitrary. As a coordinating center our big goal is to enhance the health benefits of research for Flint residents. We are not limited to adults or children, but rather taking a comprehensive approach to coordinate the research and promote community involvement (and our expertise in longitudinal studies covers the life course from infancy to older adulthood).

I was surprised when we talked to Mona because she was under the impression that we were 'staying away from kids'. I let her know that the HFRCC does not actually conduct research, rather we coordinate and bring together the collective expertise of community and researchers and that is not population limited. Mona is super protective of Flint kids and I greatly respect her dedication and feel that Flint kids deserve a champion

like her. There is also a great opportunity for us to bring the wider scientific community together to maximize the benefit of the registry to the Flint community. Getting that communicated without being a threat is the challenge AND I think we could figure it out. We are not encroaching on services for children or attempting to dilute any resources for children, but we do have the collective power through HFRCC to maximize the benefits of the registry for all populations, children included. If we took the approach of only bringing our expertise to bear for adults, it would alienate many of our colleagues and be a huge missed opportunity to support the most comprehensive data for children. Any additional help you can provide in communicating the value of including the larger scientific community vis-a-vi the HFRCC would be tremendously helpful.

Our board is refining a document that clearly spells out what value we can add to the registry and hopefully that will remedy some of the underlying concerns. We will send you and Mona a draft of that document no later than early next week. We heard you loud and clear and will figure something out and support one unified application from Flint that leverages our strengths.

Also, the language in the bill as it is published does not limit the registry to children and there will be a lot of push back from Flint stakeholders if this happens (well beyond the HFRCC). This is a separate issue but one worth thinking through before a final decision is made and publicized.

I hate long emails (so please forgive me), but I wanted to give you some things to think about in advance of the larger meeting in January.

I told Mona and Aron about tonight's meeting (and it was widely advertised) but it was primarily focused on community input (although many academics are here with vested interest in community input). I will also make sure to invite Mona and her team to our next dialogue on the 5th of January. I think these are equally valuable for community members and academic researchers.

The session is very lively and engaged. Community members have some strong, informed opinions on the research happening in Flint and some clear ideas about the registry. The most resounding message is they want the registry to include all age groups. Some of the stories people have about the impact of the water crisis on them and their families are really moving. For older adults facing multiple morbidities it is often difficult to tease out the impact of the water crisis on morbidity and mortality, but with so many unanswered questions people are left pointing to the water crisis for much of what they've experienced. And they validly want these questions answered with data and they want to be included in the process.

We will send you a summary of tonight's meeting which is being recorded via audio and transcribed after the holiday.

Below are the scenarios and questions that will be asked during each module of the pandemic portion of the exercise

### **FIRST MOVE**

In January 2017, an outbreak of the novel influenza strain H9N2 gains global attention through a large number of infections reported in London, Seoul, and Jakarta; the strain, of unknown origin, has been traced back to 48 deaths reported in Hong Kong in the previous two weeks. Health officials have characterized the H9N2 strain as similar to a virus that has circulated in birds for many years, previously causing only a small number of mild infections in humans. The virus is transmitting efficiently person-to-person, likely through respiratory routes, and health officials warn that this could become the worst influenza pandemic since 1918, which killed an estimated 30-50 million globally, including over 600,000 Americans. The demand for medical services has exceeded capacity in Hong Kong and other cities in Asia. The global community is debating whether this novel influenza strain will lead to a severe global pandemic and potential impacts to the United States. The World Health Organization (WHO) has called on antiviral drug manufacturers to deliver additional supplies and has also requested that countries that are unlikely to be affected by the outbreak donate from their stockpiles. Many countries have banned travel to affected nations. The U.S. has implemented a travel advisory but has not banned travel, allowing medical personnel and response officials to respond. There are not yet any reported U.S. cases, though experts speculate that the virus may soon arrive due to heavy travel between the U.S. and Asia.

FLINT, MI -- The state has dropped plans for an invitation-only "town hall" meeting to discuss the condition of the Flint water system after officials were questioned about restrictions on who could attend.

A spokeswoman for Flint Mayor Karen Weaver said Tuesday, Jan. 3, that "organizers of the town hall ... agreed to make the event open to the public" at the mayor's urging after city and state officials were asked about the program by MLive-The Flint Journal.

Information sent to one individual initially invited to the Jan. 11 town hall said attendance would be restricted and that tickets were non-transferable.

A live stream of the event was and is still planned so that everyone has access to information presented, Tiffany Brown, a spokeswoman for the state Department of Environmental Quality, said in an email to MLive.

Kristin Moore, a spokeswoman for Weaver, initially referred questions about the town hall to the DEQ, a co-sponsor of the event, but Moore said later that the mayor had pushed to open up who could attend the program.

"She feels everyone who wants to be part of the discussion should be since this water crisis has impacted everyone in the city of Flint," Moore's email said.

Brown said no one would have been turned away from the meeting until the Northbank Center at the University of Michigan-Flint was at its capacity of just over 300 people.

"It was important that we had a reasonable size location that was also conducive to a productive exchange of information," she said.

Coming one day after a "Flint data summit" hosted by the U.S. Environmental Protection Agency in Chicago, the town hall meeting has the potential to be a key development in the Flint water crisis.

A promotional flier says the meeting will "provide an update on the status of the Flint water system, explain the latest testing data and discuss steps moving forward."

A panel discussion is scheduled to follow the update from representatives of the EPA, Wayne State University, Virginia Tech university professor Marc Edwards, the city of Flint and the state.

The EPA data summit was organized for scientists, including Edwards, to compare the latest data from Flint. It is not open to the public or the media, according to the agency.

Brown said the state took on the role of co-sponsoring the town hall because of the potential for important information to come from the EPA summit in Chicago.

The Flint Cares Community Coalition is also listed as an event sponsor and Weaver is listed as host.

Information about the live streaming for the town hall is not available yet, according to Brown, who said the program may also be broadcast live on a local television station.

The Northbank Center is located at 432 N. Saginaw St. and the town hall is scheduled for 6-9 p.m. Jan. 11.

The meetings come as experts from the state and Virginia Tech claim recent testing shows a decrease of lead in the city's water.

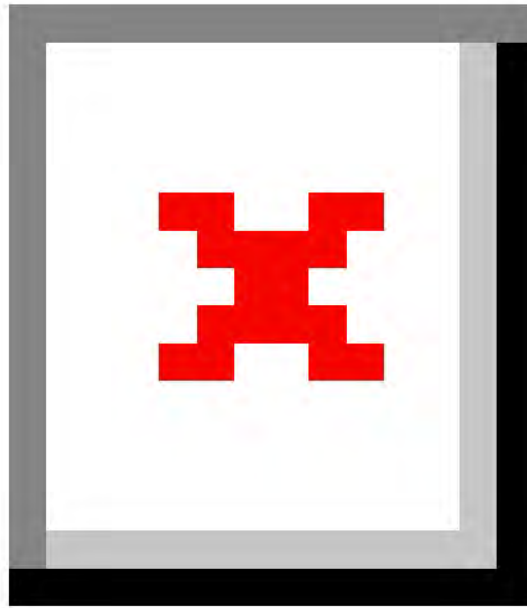
