Hello South Texas FFS Team,

As you all know, we have a number of Bangladeshi nationals in our programs, who appear to be adults. If you have dental forensics on a Bangladeshi national showing 75% or greater probability that he/she is an adult, but you have no other corroborating information, then please ask your FOJC to search that alien # and name in Bitmap for evidence of adult status. When contacting the FOJC to request Bitmap information, please include Senior Deportation Officer (b)(6);(b)(7)(F) Officer (b)(6);(b)(7)(F) email is included on this email as a CC.

If you have dental forensics showing 75% or greater probability that the individual is an adult, and you receive Bitmap information corroborating this, then the case meets ORR policy to make an age redetermination.
