Dear FOIA Ms. Mehta or Officer:

Thank you for accepting this request for public records filed under the Illinois FOIA and all applicable federal and state open records laws.

BACKGROUND: NextLevel Health Partners ("NextLevel") and its affiliates operated as a Managed Care Organization (MCO) that served Illinois Medicaid recipients through programs authorized by IDHFS. In 2020, NextLevel sought DHFS approval to sell and transfer its approximately 54,000 members to Meridian Health Plan of Illinois Inc. (a subsidiary of Centene Corp) in sales agreements that totaled \$2 million and other considerations. These sales agreements were authorized by IDHFS, according to documents.(1)

The BGA hereby requests:

- All IDHFS documents including agreements, contracts or other records showing IDHFS regulatory approval and clearance for these transfers of Illinois Medicaid members from NextLevel to Meridian/Centene.

- MCO records gathered by IDHFS including but not limited to: offer letters; sales agreements; MCO board minutes and resolutions; calculations of per member per month (PMPM) rates or other factors determining total sales cost; IDHFS' determination of the final dollar amount of the sales and transfers.

- Documents including agreements, contracts or other records showing any steps IDHFS took to ensure NextLevel and Meridian/Centene fulfill all obligations respecting the transfer of members to other MCOs, including record maintenance, access and reporting requirements, and any obligations to subcontractors, providers or Medicaid clients.

- Any records showing IDHFS required the transaction parties to complete a readiness review or other process before the transfer of Illinois Medicaid members under the Sales Agreements.

- Any records showing IDHFS or the transaction parties offered transferring members the choice of MCOs outside the normal open enrollment process and assignment by IDHFS when appropriate.

- Any dockets or other records showing the calendar for IDHFS review.
