The dental results for the one Bangladeshi UAC at SWK Rio Grande came back with a median age of 17.6. The report stated that there is about a 40% chance this youth has reached his 18<sup>th</sup> birthday. Further, the program and FFS believe the youth appears to be a juvenile.

The youth admitted to having a passport stating he was 21 years old, which was switched out in Mexico. He stated that he received a false passport in Bangladesh reporting to be 21 years old. The youth stated that he needed to have a passport showing him to be an adult in order to pass through airports until Bolivia. When the youth arrived in Panama, he stated the smugglers he met there took his falsified passport, and they linked him to other smugglers upon arriving in Mexico. Once he arrived in the US he said he reported his true DOB and age – 17 years old.

Therefore, based on the dental results and ORR policy, this youth is considered to be a juvenile.

I am still pending results from the 5 from BCFS. I was told that their dental appointment has been moved to tomorrow (10/25/2018) morning. I will update you with the results once they are received.



Regarding the interview with the UC (b)(6) he is already age out, he is 18 years old according to the BC information, assuming he is (b)(6) Like I mentioned previously we can only verify the information in their BC, and in no way attest they are the person in the BC. But according to his interview he came in on the beginning of January 2017. He doesn't have any direct family member, only a cousin. When asked about his family in Honduras he was able to give me the names of the mother and little half sister. Strangely enough he didn't know his other 2 brothers names, which casts doubt on his identity. His goal is to look for work in the US, doesn't seem he is running away from anyone in Honduras like the gangs. Hopefully this information will help you.



The dental results for the one Bangladeshi UAC at SWK Rio Grande came back with a median age of 17.6. The report stated that there is about a 40% chance this youth has reached his 18<sup>th</sup> birthday. Further, the program and FFS believe the youth appears to be a juvenile.

The youth admitted to having a passport stating he was 21 years old, which was switched out in Mexico. He stated that he received a false passport in Bangladesh reporting to be 21 years old. The youth stated that he needed to have a passport showing him to be an adult in order to pass through airports until Bolivia. When the youth arrived in Panama, he stated the smugglers he met there took his falsified passport, and they linked him to other smugglers upon arriving in Mexico. Once he arrived in the US he said he reported his true DOB and age – 17 years old.

Therefore, based on the dental results and ORR policy, this youth is considered to be a juvenile.

Yes, that is all there is. We don't sign the memo's. A memo typically does not have a signature as I don't even have access to a scanner with my work computer so I cannot sign it, scan it, and return it. ICE FOJC has never asked us to sign it. I can do an electronic signature only if you would prefer.

If you have a preferred format for these memos, please let me know. It is straight forward information that is required to state he is an adult and I was told that is all that is necessary to report.

In fact, the ORR policy and agreement with DHS only requires a memo be complete when we are submitting for pick up using a dental forensic. Otherwise, we are not required to do a memo on these types of age determinations and were doing them for consistency and courtesy. Only in our region do we submit them.

I have attached the false birth certificate the individual's family provided to the ORR shelter. The shelter had concerns he was an adult and followed our

internal processes and this was submitted to the Guatemalan consulate for verification. The consulate replied sending the RENAP from their system with his real DOB.

ORR is requesting that ICE make arrangements to pick up this adult.

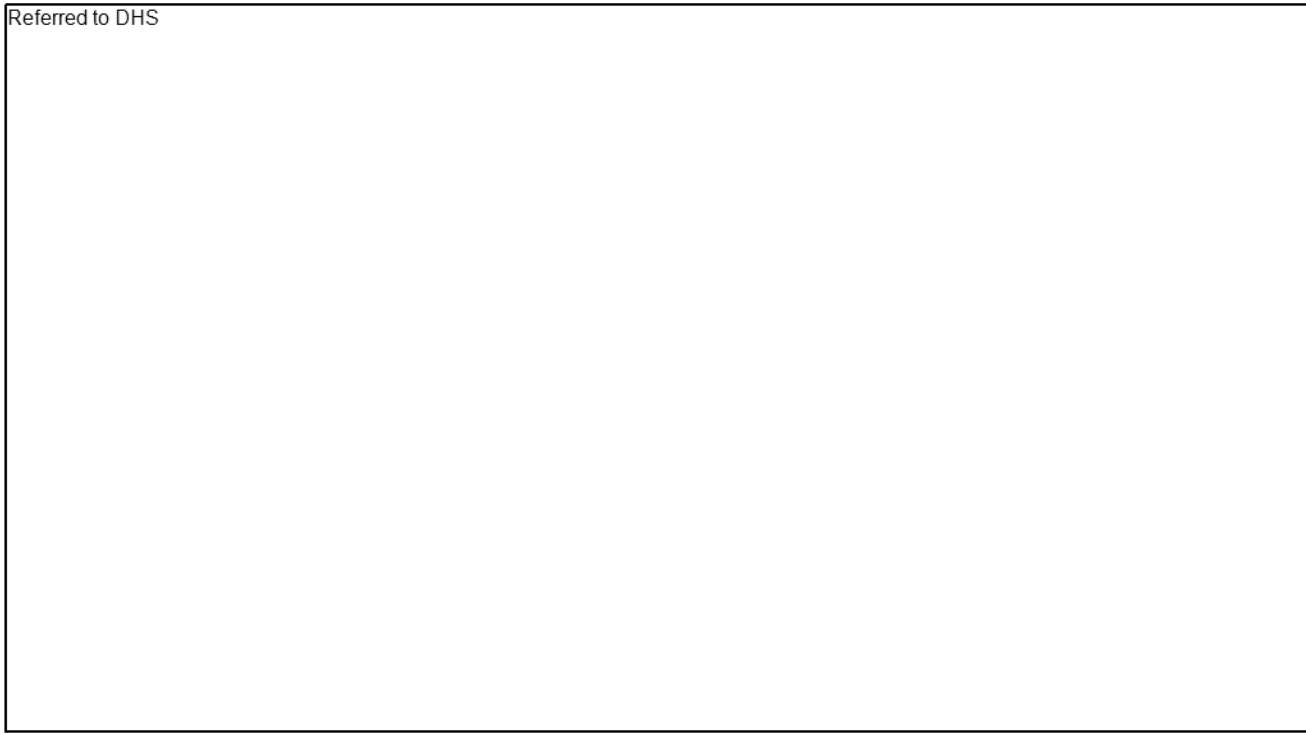



Yes, that is all there is. We don't sign the memo's. A memo typically does not have a signature as I don't even have access to a scanner with my work computer so I cannot sign it, scan it, and return it. ICE FOJC has never asked us to sign it. I can do an electronic signature only if you would prefer.

If you have a preferred format for these memos, please let me know. It is straight forward information that is required to state he is an adult and I was told that is all that is necessary to report.

In fact, the ORR policy and agreement with DHS only requires a memo be complete when we are submitting for pick up using a dental forensic. Otherwise, we are not required to do a memo on these types of age determinations and were doing them for consistency and courtesy. Only in our region do we submit them.

I have attached the false birth certificate the individual's family provided to the ORR shelter. The shelter had concerns he was an adult and followed our internal processes and this was submitted to the Guatemalan consulate for verification. The consulate replied sending the RENAP from their system with his real DOB.

ORR is requesting that ICE make arrangements to pick up this adult.

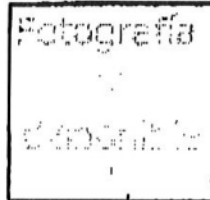

This weekend ORR was advised that some of the Bangladeshi UAC referred by DHS may be fraudulently claiming to be UAC. DHS ICE ERO and CBP have been working together to gather documents not known to exist, e.g. passports, from other DHS non-

ERO agencies. DHS has identified approximately 145 of potential adults posing as UAC. Please work with DHS ICE ERO to identify cases in your area and work on next steps for age redetermination if necessary. ICE representatives who can best assist you are copied.
