On April 19, 2010, a white female by the name of Jacqueline Stephens came to 180 Spring St, Dept. of Homeland Security. Ms. Stephens went to Judge Cassidy's courtroom to observe a court hearing. Judge Cassidy advised Ms. Stephens that she could not sit in on the hearing. At that time Ms. Stephens began to be disorderly while in the courtroom. Supervisor [REDACTED] came to the lobby and asked us to remove Ms. Stephens. [REDACTED] responded to the waiting room where Ms. Stephens was. Upon arrival, I advised Ms. Stephens that it was time for her to leave the building. Ms. Stephens asked why she was being asked to leave. I explained to her that she was not allowed to be in the courtroom at that time and it was time for her to leave. Ms. Stephens asked who wanted her gone and wanted my name. I again asked Ms. Stephens to get up and exit the building. Ms. Stephens again asked who wanted her gone and got up and began to exit the building. While escorting Ms. Stephens, lead Officer [REDACTED] helped up to escort her out of the building. When we got to the lobby, Ms. Stephens stopped and got in my face asking what my name was. Lead Officer [REDACTED] placed her hand on Ms. Stephens back and asked her to leave. Ms. Stephens left the building without further disturbances. At 1547, Insp. Picciolo was called and informed of what happened. Insp. Picciolo advised me to call BMC and to do a 3155. BMC was called at approx 1550. EOR
