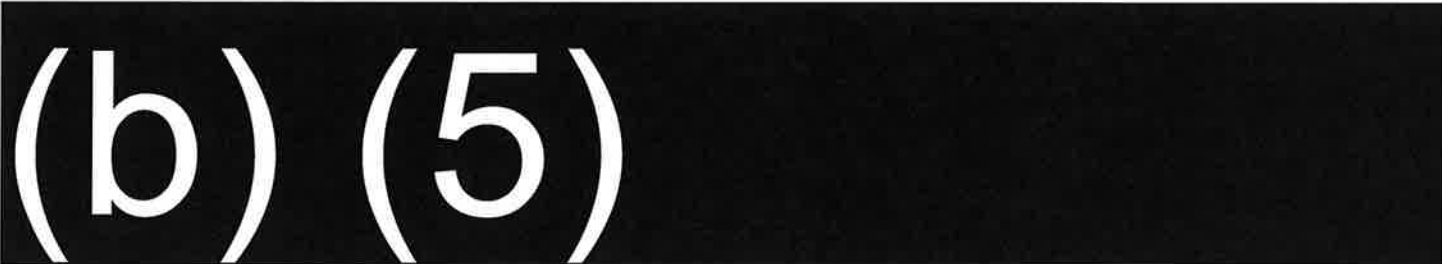

Hi Lauren,

Good morning. I'm checking in to see if by now you aware of any explanation on the part of Judge Cassidy for the incidents on Monday afternoon. If so, can you please share this with me now or let me know when you might be able to do so?

I am giving a legal education lecture on immigration law enforcement to civil rights attorneys today and I know my colleagues will be interested in hearing more about what transpired. If you have something now, that would be great. (I forgot about this, so will have to delay posting something on my blog.)

I honestly have no idea what he was thinking when he ordered this illegal action, other than that Cassidy was retaliating for my asking him why he was closing a hearing, and my earlier publications on his unlawful deportation of a U.S. citizen, my affidavit challenging claims in a vindictive complaint against a practitioner he filed (that the FL bar found without merit), as well as my challenging of an earlier occasion on which he demonstrably closed a hearing to me without legal justification.

The above are all grounds for him not to appreciate my presence in the building but none are grounds for ordering me removed, regardless of whether that order is binding.
